2. The internal administration including financial affairs of the West Bengal State Council of Sports will be dealt with exclusively by the Secretary, Assistant Secretary of the Council under the overall guidance and direction of the Chairman of the said Council.
3. The Governor is further pleased to direct that the Working Committee shall constitute the Standing Committee of the Council.

The function of the Standing Committee will be to monitor progress of various schemes and to sanction grants to individuals and associations for various purposes including conduct and organizing of the State, National and International Sports meets as also to recommend proposals to the Government after careful examination and with adequate reasons.

The Standing Committee shall also formulate sports plans including organizing coaching camps in various sports and games in Kolkata as well as in the districts in collaboration with the District Council of Sports.
